#### General

- Field limited to 64 players chosen by WPA rankings, WPA member federations' rankings, qualifiers & promoter wild cards.
  - 16 WPA rankings
  - 7 APBU (Asian Pocket Billiard Union)
  - 7 EPBF (European Pocket Billiard Federation)
  - 6 BCA (Billiard Congress of America)
  - 3 CPB (Confederacion Panamericana De Billar)
  - 2 AAPA (All Africa Pool Association)
  - 2 OPBA (Oceania Pocket Billiard Association)
  - 4 Host wildcards
  - 1 WPA Wildcard
  - 16 Qualifiers
- WPA rules of play
- Alternate breaks
- Referee racks players may not approach or inspect the rack
- 40-second shot clock on the feature table only. For the other tables, the referee will monitor and enforce the WPA slow play rule if necessary.

#### Stage 1

- All 64 players
- Double elimination to the final 16 players (8 on winners' side & 8 on the one-loss side)
- Race to 8

#### Stage 2

- Final 16 players from Stage 1
- Single elimination
- Random draw will determine new bracket placement (one-loss side player vs undefeated player)
- Race to 10

#### Dress Code

The following dress code will be strictly enforced. CSI has sole and final authority on all rules & regulations, including the dress code.

#### Approved Clothing

- Dress pants or casual slacks.
- Polo or button-down style shirt with sleeves, fold over or vertical collar. Button-down shirts may be worn unbuttoned if they are worn with a neat and tasteful undergarment. Button-down shirts worn without an undergarment may only be unbuttoned one button below the neck button or as deemed appropriate by the Tournament Director. Shirts should not be excessively loose or revealing.
- All footwear must be close toed and be normal in its style and wear. Shoes with laces must have the laces properly tied. Dark color tennis or walking shoes are acceptable but must be clean and neat.

#### **Prohibited Clothing**

- Athletic wear of any kind, including but not limited to sweats, swimwear, jogging suits, uniforms, jerseys or any type of pants with contrasting stripes not associated with formal wear.
- Shorts of any kind, regardless of apparent length. Pants must be normal in respect to the appropriate rise in relation to the length of garment and may not be excessively baggy or loose fitting.
- Overalls, coveralls, jeans, hats, headphones or ear pieces (unless medically needed written medical proof required)

#### Sponsor Logos and Patches

Players may wear a maximum of three (3) logos on playing apparel ("player's logos"). All logos, including apparel brand logos, are included in this maximum of three (3) restriction. Logos may not exceed six (6) square inches. The player must submit to CueSports International (CSI), before his or her first match, samples of all sponsor logos for approval. CSI reserves the authority to disallow any sponsor logos for any reason, including but not limited to not submitting logo for approval or conflicting with any other event or broadcast sponsor. Additionally, CSI reserves the right to require any player to display event sponsor logos on the player's apparel in addition to the threeo (3) logos allowed.
